	Focus of group on upcoming election, after which they will be switching focus to ongoing consultation and advocacy with local elected officials
	Social Media Survey Campaign – gathered feedback from people with lived experience of core issues related to poverty, helping to ensure the priority table has a focus that aligns with people's experience
	An election toolkit and policy paper will be sent to NPRN members after today's meeting
	• Strategic role of nonprofits is to help facilitate civic engagement and provide information to those that we serve and provide support with accessing a ballot and election site (ID, vouching, transportation)

- Elections Canada materials will also be sent out and can be printed and hung within your offices (e.g. Voter's Checklist; Having ID; list of candidates running; when and where to vote)
- Roundtable Discussion regarding Elections
  - Barriers facing newcomers especially, include a lack of comfort with the democratic system (sometimes based on previous experience of corrupt governments), language barriers, etc. How do we make sure we include newcomers?
    - Suggestion that we include information from Folk Arts and Multicultural Centres/look to these organizations for resources
    - There are Elections Canada materials available in many languages, and presentations can be made by Elections Canada representatives if requested
    - Recognition that not all newcomers are eligible to vote, so there is information sharing needed for that issues as well
    - There is the possibility of using community and religious networks that are used frequently by newcomers to share information
  - o Regarding those experiencing homelessness, there is often a feeling of being "let down" by the government
    - Difficult to engage in a conversation about being proactive due to the stress of the realities of living in poverty hard to look
      at political fight when there is just a fight to survive message we can share is that 'if we sit and do nothing, then nothing
      will change'
    - This population tends to feel invisible and discarded so how do we encourage the thinking that "why would I vote if I'm not even a part of society"
  - o Barriers to those living with low income, also include difficulty to leave work to vote
  - Elections Canada has all available information regarding any parties running and their platforms worth us encouraging our community/clients to look for information beyond what the media provides
  - Vouching system more information on Elections Canada, but can only vouch for one person that lives within your same voting station. (CLICK HERE: found under "Policy Requirements - How does an elector prove identity and residence? – Option 3"
  - Age Friendly Network of Niagara put together candidates brief that is available online <u>HERE</u>
  - o Difficulty to find non-partisan rides to polling station
    - If partisan rides are the only way to get people to polling station, it is still worth considering especially with guidance from staff etc.
  - o For people without ID, medical bracelets can count
  - o Encourage connections with actual elected officials, e.g. monthly conversations happening in Queenston Community Group
  - Quest had drop-in information about how to access voting, as well as computers available to research platforms and policy –
     were able to engage quite a number of people engage and follow through
    - Also offered bus passes for polling
    - Had this set up in the Quest waiting room, to encourage engaging with elections
    - Suggestion other organizations might be able to do something similar
  - Suggestion that as we move forward we continue to think about barriers that exist for people and connect with NPRN about what we can do about it
    - Hoping to encourage NPRN members to act as liaisons with people, and to start conversations happening just start somewhere, and every person engaged counts

#### **Presentation**

Benefits, Credits, Services Presentation: Pearl Toy, Outreach Officer, Canadian Revenue Agency

- Child Benefit Has been discussed that Ontario portion will be cut under the Ford government this benefit is available for people who are non-status residents who need payment to help with child expenses (this is the only benefit available for non-status residents)
- Applying for Disability Tax Credit (DTC) important emphasis that the form needs to be filled out by a medical practitioner it is the
  medical practitioner portion that is most important as the eligibility for the credit is based on the effects that an impairment has on
  a person, not on the medical condition itself
  - o If it costs the person applying to have a medical practitioner fill this form, that cost can be counted as a medical expense on their taxes
  - Not encouraged to put this in with tax returns can take 16-18 weeks to process, and will delay the taxes being fully assessed thus a delay to all transfers and payments
  - After it is reviewed, a letter of determination will be sent with a date this is approved for (can be no end date, where no re-application is necessary); if end date, a letter will be sent reminding of re-application needed
  - o More information can be requested of the medical practitioner
  - o If there ever is a letter sent asking for more information, it is very important information be sent if letter isn't answered, there will be no continued review or approval of DTC
  - O DTC can be transferred to someone else, but the person that can receive the transfer needs to ask for a tax adjustment themselves
  - A copy of the application should be retained, for future reference. If the application is not approved, an objection can be filed (a more formal process). If still not approved, they can go to tax court. There is a 90 day time frame from the receipt of the disapproval letter.
  - o If a condition changes, more information can be provided to CRA and an application can be reviewed
  - Key that an applicant and medical professional take time to fill out 'mandatory sections' to provide enough information more information can be found HERE
    - There are also payment calculators you can use that are pretty accurate
  - Children can apply the applicant of the parent claiming it (may be worth the parent who is the higher earner applying, but credit can be divided between parents)
- Child Disability Benefit
  - o Can be transferred, can be used on own tax information, but after 18 they will not be eligible
  - If a child has been approved for CDB without end date, the benefit will continue as an adult benefit; if there is an end date, the child will have to reapply
- GST/HST
  - o Newcomers have to apply, otherwise it is automatically assessed on your taxes
  - With common law or married partners, only one person per family will receive this
- Working Income Tax Benefit
  - o Must fill out Schedule 6 (this will calculate amount of payment)
  - Can apply to receive 50% of their WITB in advance payments (separate form)
  - o If they are also eligible for the disability tax credit, they may get a disability supplement

- Name of this payment is being changed to Working Tax Credit at this point, you won't have to fill out Schedule 6 unless you
  have exempt status
- Calculator Canada.ca/child-family-benefits-calculator
- Some companies are promoting that they can apply for the disability tax credit, but take portion worth being wary of costs and what will be taken (can be % of all tax credits, including previous years adjustments)
  - Canadian government never endorses any company
- Remind clients that personal information needs to be kept up to date especially address if returned mail comes back, all payments will stop until information is updated
- Encourage that direct deposit is signed up for, can be set up online (My Account; My CRA)
  - o My account is set up through Service Canada can see some information about their taxes
- You don't need a bank account to cash government accounts –all banks have to cash cheques up to \$150

- Community Volunteer Income Tax Program
  - CRA partners with organizations to have volunteers do free tax returns for free for individuals with modest incomes and a simple tax situation
  - o This serve runs all year round, with more clinics in tax season (Feb-Apr)
  - o Can find locations of clinics at Canada.ca/taxes-help

#### **Health Equity**

- Have been supporting a local research group from McMaster called HEART project that looked into people with lived experience of homelessness and their experience of the health care system
- Out of this project saw recommendation was to provide more support, especially peer support
- Received various funding, including Ontario Trillium Foundation
- Funds are being used to create team of peer support workers that can provide direct ED support (general support, as well as advocating and system navigation, and connection with different community agencies) and Project Coordinator (in process of recruiting this position, after which will support peer support workers)
- Research component has been approved for the pilot project, and Steering Committee is in place Steering Committee will take over the work that Health Equity has been done
- Work is starting in October in Niagara Falls, then rolling out to Welland, and possibly St. Catharines
- Also doing some work around the Mobile Health Screening bus as provincial funding has been cut some work has been done for media campaign that will help share information about these cuts and the importance of keeping this program active
- We are now open to new tasks/projects, if you have ideas please or would like to attend the group, reach out to Rachel

#### Marketing & Communications

- Group met this week, working on developing social media awareness group will be doing media posts related to particular days (e.g. National Housing Day, National Living Wage Week, etc.)
  - Will be relating poverty back to these particular themes
- Also starting to put together brochure for NPRN, based on updated Terms of Reference and Orientation documents we already
  have
- Looking into NPRN membership and membership expansion have letter going out to a significant number of organizations that represent broader sectors

## Wages & Work

- Updating annual cost of living/living wage calculations these are currently under review by the Ontario Living Wage Network
- Will be publicly released during Living Wage Week in November, 2019
- Reaching a milestone today, certifying 26<sup>th</sup> living wage employer with a total of +1000 employees now living wage employed in Niagara
- This table doesn't meet regularly, and instead on as needed basis as the foundation of the work has been laid at this point

- Since May, have been engaged with a few municipalities has been a bit complicated for some municipalities to bump up contract positions
